
# **Plan vs. Performance**

The Winter Session of Parliament adjourned *sine die* on December 16, 2016. Several hours were lost due to disruptions over the issue of demonetisation of currency notes. Rajya Sabha discussed issues related to demonetisation and delay in landing of an aircraft carrying the Chief Minister of West Bengal. Supplementary Demand for Grants (Appropriation Bills) was discussed and passed only by the Lok Sabha. Given that these Appropriation Bills were not returned by Rajya Sabha, they will be deemed to be passed within 14 days of their reference to the Rajya Sabha. (Reference date: December 9, 2016).

Eight legislative Bills were introduced during the Session and two were passed. One Bill was withdrawn. Lok Sabha worked for 15% of the scheduled hours and Rajya Sabha for 18%.
