Input–Output Table for India: 2013-14

Kanhaiya Singh¹ and M.R. Saluja²

SYNOPSIS

The input–output table for India has been constructed for the year 2013-14 consistent with the National Accounts estimates given in the National Accounts Statistics (NAS) 2015, while the supply use table (SUT) is for the year 2012-13. In order to allow for comparisons with the 2007-08 input-output table, the number of sectors has been kept the same. The validation has been done by physically comparing the output multipliers for these two tables. The 2012-13 SUT has 140 rows and 67 columns, which have been collapsed and expanded, respectively, to make the 130 x 130 input-output table.

1. INTRODUCTION

In economics, an input–output (I-O) model is a quantitative technique that represents the linkages and interdependencies between outputs of different sectors of a national/regional economy.

The origin of input–output tables is attributed to the work of Wassily Leontief (1906–1999), who earned the Nobel Prize in Economics for the development of this type of analysis. However, some economists have argued that the work of Wassily Leontief with regard to the input–output model was influenced by the works of the classical economists Karl Marx (1818–1883) and Jean Charles Léonard de Sismondi (1773-1842), and the analysis of general equilibrium by Leon Walras (1834-1910) and some others.³ Nevertheless, the importance of input–output analysis lies in the powerful mathematical representation of the interdependence of industrial activities provided by Wassily Leontief that allows for estimation of the impact of the final demand of any sector on all the other sectors and the economy as a whole.

Basic Structure of Input–Output Tables⁴

At the heart of the input–output model is a square matrix of the inter-industry transaction for an economy, which shows how the output from one sector may become an input to another industrial sector. In a typical inter-industry matrix, the economy is presented such that each industry listed across the top represents the consuming sector ('j') and down the table, each row represents the producing sectors ('i') (Table 1). Thus, the output from the row sector is distributed as an input to all the sectors mentioned in the respective headings of columns plus the final demand to make it a closed model. The dependency of one sector on every other sector is underlined as a supplier (of the input) and customer (user of the output) type of relationship. In a typical input–output matrix, all the entries are made in monetary value terms. Separate columns are used to account for net exports, capital formation, private final consumption expenditure, and government final consumption expenditure to close the model.

The structure of a typical I-O table is presented in Table 1 in a simplified way. The columns represent the user industry, and the table has three sections, namely the intermediate user sectors ('j_s'), final user sectors, and the total output. The rows also have three sections, namely the producing sectors ('i_s'), value added, and output. The user and producer section is a square matrix and represents industrial activity 'F_{ij}', which means that the amount of output of sector 'i' going to sector 'j' as input. Thus, the output of industry 'j' is the sum of inputs from 'n' sectors mentioned in the rows plus value added. The column sums are equal to the row sums so that the total output is equal to the total use.

At the core of I-O accounting are two basic accounting tables, namely: a “supply” table and a “use” table.

The supply table is the industry x commodity table, where the rows represent the industries, whereas the columns display the commodities produced by the industries. It is assumed that several commodities can be produced by each industry or a particular commodity can be produced in several industries. Thus, the sum of the row series is the output of that industry, while the sum of the column vector is the output of that commodity.

The use table is the commodity x industry table, wherein the uses of commodities are distributed among the intermediate user (purchaser) industries and final users. The rows in the use table present the commodities or products while the columns display the industries and the final users of the products of these industries. Thus, the sum of the entries in a row is the output of that commodity, while the sum of the column entries is the total of commodity input consumed by each industry. The total output of each industry listed in the columns is obtained by adding value added; taxes on production and import taxes net of subsidies; and the total value of the commodities going as inputs for production by that industry.

Fundamental Assumptions with Respect to I-O Principles

The preparation of I–O accounts is a complex process involving the collection and integration of data from a variety of sources, which may or may not be available on an annual basis. Therefore, consistent approximations are required to provide a meaningful structure of economic activity. The following three basic principles guide compilation of the input–output system:

(1) *Principle of homogeneity*: It is assumed that the output of each industry is produced by using a unique set of inputs as required by the use table. However, this may not be possible in practice because of the multiplicity of products produced by each industry as captured in the supply table, and each of the products may require considerably different inputs.

(2) *Principle of proportionality*: It is assumed that there is no economy of scale in the use of inputs for producing products from various industries. This effectively means that the ratio of each input to one unit of output remains constant for all levels of output. Thus, in the use table, if the final demand for output of product “A” increases by 10 per cent, all the inputs will also increase by 10 per cent.

(3) *Principle of consistency*: It is assumed that the classification of data of the input–output tables is in accordance with that of the National Accounts Statistics in order to allow for comparison of aggregate results such as gross value added of the economy, and total final demand, among other things.

Uses of the I–O Tables

Input–Output tables have several applications. However, the prominent applications include impact assessment of specific economic events involving a change in final demand or conversely assessment of the investment and production requirements for meeting the expected future demand of other sectors. For example, it entails an understanding of the preparatory requirements for doubling of food production or an understanding of the options available for increasing the income accruing to a certain sector.

I–O tables are also used to analyse the impact of changes in the output and price structure of the economy on the other sectors and on the economy as a whole. For instance, this entails an analysis of the effects of exogenous change in the production of petroleum products.

Recently, the input–output framework has also been used for preparation of satellite accounts such as tourist satellite account or health satellite account for the economy.

The important components of impact analysis include estimation of the direct and indirect effects arising from changes in the final uses on: (a) industry and commodity output, (b) employment, and (3) income.

Several forecasting models and computable general equilibrium models use input–output tables for linking the flow across sectors.

The input–output analysis starts with the calculation of input–output coefficients by dividing each entry of the I-O table by the corresponding column total. For the industry section of the table, the input–output coefficients are in the form of a square matrix “A”, which is used to estimate various multipliers as shown in Equations (1) to (3).

When “A”, which is the input–output coefficient matrix, is subtracted from an identity matrix “I”, the resulting (I–A) matrix is known as the Leontief matrix and $(I-A)^{-1}$ is the Leontief inverse matrix. Various multipliers can be obtained by using the Leontief inverse matrix like the output multiplier, employment multiplier and income multiplier, which provide estimates of direct and indirect effects resulting from changes in the final demand of a sector.

2. HISTORY OF INPUT-OUTPUT TABLES IN INDIA

The analytical power of input–output analysis, demonstrated through a series of works by Wassily Leontief and others, motivated several countries to create feasible, reliable and accurate I-O tables. By now, I–O tables have been constructed for more than 100 countries. In India, a beginning was made in this field by individual researchers in the early 1950s. Thereafter, a number of input–output tables were prepared at both the national and regional (state) levels (Saluja 1980).

However, at the official level, the first all-India input–output table was prepared for the year 1968-69, jointly by the Central Statistical Organisation (CSO) and the Planning Commission, and it consisted of 60 sectors (NAS January 1978). Since 1973-74, the CSO has been constructing and publishing these tables along with auxiliary tables and reports on methodology and data sources at an approximate interval of 5 years. The latest table relates to the year 2007-08. Prior to that, the official I–O tables (brought out by the CSO) were prepared for the reference years 1968-69, 1973-74, 1978-79, 1983-84, 1989-90, 1993-94, 1998-99,

and 2003-04. These publications include the main tables as well as supplementary tables on input structure and the commodity composition of output; methodology; sources of data; and a brief analysis of the results. The methodology followed is almost the same for each year.

The published tables for 1989-90, 1993-94 and 1998-99 are for 115 sectors of the economy while for the earlier years these relate to 60 sectors only.

The tables for 2003-04 and 2007-08 have 130 sectors. Over the years, there has been an improvement in the methodology and reliability of the data required for the construction of I-O tables in India. However, certain issues still need to be resolved.

Shift to Supply Use Table (SUT) and New Series of National Accounts Based on the System of National Accounts 2008⁵

The CSO brought out the new series of National Accounts Statistics in January 2015 with the base year being 2011-12, using new data sources and incorporating some of the recommendations of the System of National Accounts, 2008 (SNA-2008). Along with the new NAS, the CSO has also, for the first time, compiled and published the Supply and Use Table (SUT) with 140 products and 66 industries of the Indian economy for the years 2011-12 and 2012-13. The SUT includes the complete table, the details of the methodology adopted, and the database used.

The reason for the above-mentioned shift is highlighted in the Preface of the 'Note on Compilation for the Years 2011-12 and 2012-13', which states: In Indian National Accounts Statistics due to disparate data sources, the GDP derived from the production side and the expenditure side often do not match and the differences are termed as statistical discrepancies. This can be obviated with the compilation of the Supply and Use tables (SUT), which offer a detailed analysis of the process of production and the use of goods and services (also treated as products) and the income generated in that production." In earlier exercises, the CSO used to produce the 'make matrix' and 'absorption matrix', which have now been broadly renamed as the supply and use tables with an emphasis on the methodologies prescribed in SNA-2008.

The SUT framework focuses on the flow of production in an economy showing where goods and services are produced and where they are used as indicators of intermediate consumption, final consumption, gross capital formation and exports. The SUT framework leads to mutually consistent estimates of macro-economic aggregates such as GDP, components of value added, imports, exports, private final consumption expenditure (PFCE), government final consumption expenditure (GFCE), and gross fixed capital formation (GFCF), among other things. A well-structured SUT is helpful in balancing the supply and demand within the economy, and subsequently, compilation of the GDP figures.

It is, therefore, claimed that SUT provides a better description of the economy at the aggregate level with respect to production processes, interdependencies in production, the use of goods and services, and generation of income through production.

The supply use equation for any given product in an economy is mathematically expressed as follows:

Output + Imports = Intermediate consumption + Final consumption + Gross Capital formation (including changes in stocks and valuables) + Exports.

In order to maintain the mathematical identity, adjustments are needed for price differentials in respect of each items on both sides of the equation to get them converted to the same (purchaser's) price level. Since output is at basic prices, taxes, net on products need to be added on the left-hand side. Accordingly, the above equation has to be re-written as follows:

Output - Intermediate consumption + Taxes on products - Subsidies on products = Final consumption (government and private) + Gross capital formation (fixed, changes in stocks and valuables) + Exports - Imports.

The private Final Consumption Expenditure (FCE) includes both the household FCE and FCE of Non-profit Institutions Serving Households (NPISH). It may be noted that the left-hand side and right-hand side in the above equation represent the GDP at market price and expenditure components of GDP, respectively.

3. NEED FOR INPUT-OUTPUT TABLE FOR 2013-14 BASED ON SUT

The CSO has not published I-O tables after the publication of the 2007-08 tables. It may be mentioned that the application of SUT has been greatly enhanced after conversion of the tables into a symmetrical matrix of flows of commodities (Commodity X commodity: (C X C) Matrix).

It is with this objective that an attempt has been made to create a symmetric C x C matrix for the year 2013-14 using the SUT of 2012-13. Various multipliers including the output multiplier, income multiplier, and employment multiplier obtained from the resulting C x C matrix have been used for impact analysis of an infrastructure project study undertaken by the National Council of Applied Economic Research (NCAER).

4. METHODOLOGY OF CONSTRUCTION

The objective here is to prepare 130 x 130 commodity-commodity matrix comparable to the 2007-08 I-O table of India consistent with the SUT published by the CSO as mentioned above. It may be noted that the SUT has a structure of 140 sector classification of products and 66 sector classifications of industries. The following steps have been used for constructing the I-O table from the SUT. Further, the Supply Table is available at the basic price while the Use Table is available at the purchaser price. However, the trade and transport margin (TTM) and taxes on products are available for all the 140 commodities in the Supply Table.

(1) CONSTRUCTING A 130 X 130 STRUCTURE FOR THE SUPPLY AND USE TABLE

The 140 sector commodity structure of the SUT has been converted into a 130-sector structure by mapping each commodity with the structure of the 2007-08 input-output tables. While there is direct concordance between most of the sectors, some sectors need specific care to make the table consistent with the 130-commodity structure. This required both a collapsing of certain sectors as well as splitting some of them to arrive at a 130-sector structure. A list of such sectors is given in Annexure 1.

The SUTs have 66 columns of the major sectors. Out of these, agriculture as a whole has one column representing the entire 20 sectors of the Input–Output structure. The remaining 65 sectors represent the industry and services sectors. These 66 sectors have been split into 130 sectors, including 20 of agriculture and rest for industry and services. Among the industry and services sectors, there are several sectors which have a direct concordance with the 130-sector structure. In order to split the 66 sectors, the structure of the 2007-08 I–O table has been used as a first round approximation. As regards the sectors wherein inconsistencies were encountered, those have been adjusted manually. While doing this, it has been assumed that distributions at factor cost are not very different from the distributions at the purchaser prices or the basic prices.

The 130X130 use table obtained above is in purchaser prices and therefore, needs to be converted into basic prices. This has been done by making use of the ratio of the basic price to the purchaser price for each commodity as obtained from the Supply table.

Now we have 130X130 SUTs at basic prices.

(2) SYMMETRICAL INPUT–OUTPUT TABLE FOR THE YEAR 2012-13

These SUTs are used to prepare the symmetrical I–O table for the year 2012-13 by making use of the industry technology and standard methodology suggested in the handbook of input-output published by the United Nations (1999) (also see the Input–Output Table of India 2007-08, 2012).

(3) OUTPUT AND VALUE ADDED FOR 2013-14

The symmetrical I–O Table for the year 2013-14 has been obtained by making use of estimates of output and value added of different sectors of the economy as obtained from NAS 2015. The detailed item-wise output for the primary sectors and services sectors are readily available for almost all sectors as per the Input–Output structure. However, the distribution of output and value added needs to be done for the manufacturing sector, which is available at the two-digit level. This has been done by using the structure of the 2012-13 SUT.

(4) FINAL DEMAND

The private final consumption expenditure (PFCE), government final consumption expenditure (GFCE), and gross fixed capital formation (GFCF) have been obtained from the NAS 2015 and distributed according to the 2012-13 input–output structure, as mentioned above.

The data on exports and imports has been obtained from DGC (I&S), which is also readily available. The data are fairly reliable for imports and exports. Imports have been directly taken at the CIF values while the value regarding exports, which is available on a F.O.B basis, have been converted to the factor cost value by making use of trade, transport margins and indirect taxes. Then both export and imports have been changed to the basic price.

(5) BALANCING OUTPUT AND DEMAND

The final balancing of the symmetrical I–O table for the year 2013-14 has been done with manual adjustments with regard to the change in inventory and input coefficients after a close examination of the entire table.

(6) VALIDATION

Finally the estimated output multipliers have been compared with those obtaining in 2007-08.

5. RESULTS AND TABLE

The resulting 130 x 130 commodity-commodity table is presented in Annexure 2. Based on this table, the output, income and employment multipliers for the year 2013-14 have been estimated, and are presented in Annexure 3. The employment multipliers (in terms of the number of total jobs created for an additional output worth one lakh rupees) have been estimated after estimating the employment coefficients by using the employment–unemployment data for the years 2011-12 and the census results of enumeration; and subsequently deflating the same by using sector deflators to make it consistent with the 2013-14 estimates of NAS.
