Winter Session - November 22 to December 19, 2006

### Bills Passed by Parliament during the Winter Session

Short Title	Key Objectives
The Essential Commodities (Amendment) Bill, 2006	Moves the list of essential commodities to a schedule. Provides central government powers to amend the schedule. Prunes list to 7 commodities.
* The Jallianwala Bagh National Memorial (Amendment) Bill, 2006	Changes the constitution of the Trust to include the PM as chairperson, and Union culture minister, leader of opposition in Lok Sabha, Congress president, Governor and CM of Punjab, and three eminent persons as Trustees.
The Constitution (Scheduled Tribes) Order Amendment Bill, 2006	Amends "Lohar" in the Hindi version or the Order to "Lohara" for the state of Bihar.
* The Indian Rifles (Repeal) Bill, 2006	Repeals the Indian Rifles Act, 1920, which governed various police forces in princely states, as the Act has become obsolete.
The Central Institute of English and Foreign Languages University Bill, 2006	Upgrades the CIEFL, situated in Hyderabad, to the status of a central university.
* Uttaranchal (Alteration of Name) Bill, 2006	Changes the name of Uttaranchal to Uttarakhand.
The Indian Telegraph (Amendment) Bill, 2006	Permits USO Fund to be used to support cellphone service providers.
The Sikkim University Bill, 2006	Establishes a central university in Sikkim.
The Tripura University Bill, 2006	Converts the Tripura University to a central university.
The Rajiv Gandhi University Bill, 2006	Converts the Rajiv Gandhi University in Arunachal Pradesh to a central university.
* The Administrative Tribunals (Amendment) Bill, 2006	Increases the retirement age of members of the Tribunal from 62 to 65 years.
The Prohibition of Child Marriage Bill, 2006	Prohibits child marriage, permits annulment of marriage by a child, and imposes penalties on those abetting the marriage of a child.
* The Commissions for Protection of Child Rights (Amendment) Bill, 2006	Changes the chairperson of the selection committee from the Minister for HRD to the Minister for Women and Child Development.
The Central Educational Institutions (Reservation in Admission) Bill, 2006	Provides for reservation of 27% of the seats in central educational institutions for OBCs, and for increasing the seats in order to protect the number of general category seats.
The Dalmia Dadri Cement Limited (Acquisition and Transfer of Undertakings) Amendment Bill, 2006	Empowers CCI to close and sell the assets of a cement plant as provided by the rehabilitation scheme of BIFR.
* The Appropriation (No. 5) Bill, 2006	Authorises expenditure from the Consolidated Fund of India.
* The Appropriation (No. 6) Bill, 2006	Authorises expenditure from the Consolidated Fund of India.
The Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Bill, 2006	Provides certain rights including land ownership rights in forests for communities that have been forest dwellers for at least three generations.
